HOW WE USE YOUR GIFT

Tudor Hall is a well-managed and carefully financed school and we work hard to keep fees at a reasonable level. While income covers operational running costs, the School is limited in the projects and initiatives it is able to pursue. Like many girls' schools, Tudor does not benefit from a capital endowment and is increasingly reliant on the generosity of benefactors especially where long-term investment is required.

Unrestricted legacy gifts allow the School to direct funds to areas of greatest need and provide most flexibility for meeting future demands.

Restricted legacy gifts are generally directed towards our two core priorities - funding bursaries to widen access, and funding capital projects to improve facilities.

The Wendy Griffiths Bursary Fund

Tudor is committed to broadening access to the education it provides. We aim to be inclusive of pupils whose parents or guardians are on low incomes and endeavour to provide short-term financial assistance for parents who encounter unexpected financial hardship.

Tudor typically supports over sixty means-tested bursaries a year, around fourteen of which offer fee support of 100%. Legacy gifts to The Wendy Griffiths Bursary Fund help to safeguard and grow this bursary provision, making it possible for more girls to benefit in the future

Facilities and Buildings

The past 20 years have witnessed an £18million investment in facilities at Tudor. Projects have traditionally been facilitated through prudent financing and investment of fee income but, as demand increases, we have also seen the growing importance of philanthropic giving. Our plans for the future are ambitious and legacy gifts help us to provide the best learning environment to inspire and enable our girls.





TYPES OF LEGACIES

If you are considering making a gift to Tudor Hall in your Will, our Head of Development will be happy to discuss your wishes and intentions. We do however strongly recommend that you seek independent professional legal and/or financial advice when creating or updating your Will.

There are a number of different ways you can remember Tudor Hall in your Will:

A Residuary Gift

The whole or part of the value of your estate, after debts, other gifts and liabilities have been met. The advantage of such a legacy to the School is that, not being a fixed sum, it keeps pace with inflation.

A Pecuniary Gift

A specific sum of money. As the cost of living increases, the value of a pecuniary legacy will decrease over time. It is possible to index-link your gift so that the final amount received by Tudor Hall accurately reflects the original intention of your bequest.

A Specific Gift

A specific item of value such as a property, piece of art, item of jewellery, stocks and shares, or other asset. Stamp duty is not payable on outright gifts of land or buildings.

A Reversionary Gift

Your estate can provide an income to your beneficiaries during their lifetimes, and upon their deaths, pass to Tudor Hall.

A Conditional Gift

If your beneficiaries predecease you, Tudor Hall can be named as the recipient of your estate.

Codicils

If you have already made your Will, but would like to include a gift to Tudor Hall, it is a simple process to add a Codicil (see page 13).

Sample Wording for use in your Will

I will give free of tax to Tudor Hall School (Charity Number 1042783) of Wykham Park, Banbury OX16 9UR the sum of £xxxx or the whole (or x per cent share) of my residuary estate for its general purposes and I declare that the receipt of the Bursar or other proper officer shall be sufficient discharge to my Executors.

TAX BENEFITS

Any gifts you make to a registered charity in your Will, are deducted from your estate before inheritance tax is calculated and can therefore reduce the tax liability on your estate.

Tudor Hall is a registered charity (Charity Number 1042783) and consequently all legacies made to the School are exempt from UK Inheritance Tax (IHT). Under current rules, if you leave 10% or more of your net estate to charity, the Inheritance Tax rate on the whole of your taxable estate is reduced from 40% to 36%. The net value of your estate is the sum of all assets after deducting any debts, liabilities, reliefs, exemptions and nil-rate band.

The example below illustrates how this rule increases the cost effectiveness of leaving a gift of 10% or more to a qualifying charity in your Will. (Correct as at Nov 2022, for further information visit www.hmrc.gov.uk/inheritancetax).
